# PLYMOUTH COUNTY COMMISSIONERS <u>MEETING</u>

#### December 17, 2015

A regular meeting of the Plymouth County Commissioners was called to order at 5:35 p.m. at the County of Plymouth Administration Building, 44 Obery Street, Plymouth, MA. Present were Commissioner Sandra M. Wright and Commissioner Gregory M. Hanley. Chairman Pallotta was unable to attend the meeting. Commissioner Wright served as Chairman. Commissioner Wright called for the Pledge of Allegiance.

Also, in attendance were Treasurer Thomas O'Brien, Deputy Treasurer Jeff Welch, Register of Deeds John Buckley, Assistant Register of Deeds Tim White, 4-H Director Molly Lipper, County Attorney Meghan Bridges, County Administrator Frank Basler, and Executive Assistant Nancy O'Rourke.

#### Meeting Minutes-November 19, 2015

Commissioner Hanley requested the approval of the meeting minutes be tabled to the next meeting due to Chairman Pallotta's absence. Commissioner Wright concurred.

#### Vote-Vendor Vouchers

Commissioner Hanley made a motion for approval of vendor vouchers as recommended by the Treasurer. Commissioner Wright seconded.

Vote: The motion passed unanimously.

#### Vote-Payroll

Commissioner Hanley made a motion to accept and approve payroll as recommended by the Treasurer. Commissioner Wright seconded.

#### Vote-Sick Leave Buy Back-Veronica Young

Commissioner Hanley made a motion to order the County Treasurer to pay Veronica Young, 19 Longwood Circle, Kingston, MA, 02364, the sum of One Thousand, Eighty Nine dollars and Sixty Nine cents (\$1.089.69) to be paid from the Plymouth County FY 2016 Budget, as said Veronica Young retired from the position of Land Records Assistant at the Plymouth County Registry of Deeds, on November 13, 2015 with 318.25 hours to her sick leave credit. The amount of sick leave buy back is 20% or 63.65 hours at the rate of compensation of \$17.12 per hour.

#### Hiring Sub-Committee Registry Liaison

Commissioner Wright made a motion to rescind the appointment of Chairman Pallotta to the Hiring Sub-Committee for the Registry of Deeds. Commissioner Hanley seconded. Vote: The motion passed unanimously.

#### Interviewing and Hiring of JG-1 and JG-2 positions for Custodial Union

Commissioner Hanley requested the discussion on hiring temporary and permanent custodians be tabled to the next meeting to allow Chairman Pallotta to participate in the discussion. Commissioner Wright concurred.

## Plymouth County Fire Mutual Aid Communications Dispatch Feasibility Study

Commissioner Hanley made a motion to have the county move forward with administering of an RFP for a feasibility study on behalf of the Plymouth County Fire Chief's Association. The Fire Chief's Association will fund the advertising and any other costs associated with the RFP process. Commissioner Wright seconded.

Vote: The motion passed unanimously.

# Lease-DA's Office-32 Belmont Street, Brockton

County Administrator Frank Basler briefed the Commissioners on the status of the expired lease between the county and the district attorney's office. Administrator Basler has been negotiating terms of the lease with an increase in rent but has not been successful given the time frame that has elapsed this fiscal year. The Administrator will seek a rent increase when negotiating the 2017 lease. Commissioner Hanley made a motion to allow Administrator Basler to enter into an agreement to extend the lease for FY 2016 at the current rate. Commissioner Wright seconded.

Vote: The motion passed unanimously.

## Lease-Congressman Lynch's Office-155 West Elm Street, Brockton

Commissioner Hanley made a motion to authorize Administrator Basler to enter into a lease agreement to extend the lease with Congressman Lynch for the space he utilizes at 155 West Elm Street, Brockton. Commissioner Wright seconded.

Vote: The motion passed unanimously.

# Power Management Electricity and Natural Gas Contract

Administrator Basler briefed the Commissioners on meetings held with Kevin Kelly and his team from Power Management to secure favorable rates for the County electricity and natural gas. David Cohen from Power Management appeared before the board to inform the Commissioners that the last two years, the County has locked a very favorable rate as we bought in near the bottom of the market. We are currently at 8.8 cents per KW and \$7.78 per Dth. Mr. Cohen recommends the County lock in for a two year period and rates would stay very low at 9.03 cents per KW and \$6.365 per Dth for gas. Potential projected savings is \$36,000 per year compared to the public utility. Commissioner Hanley made a motion to enter into a 2 year agreement as recommended by the consultant Power Management and to authorize Administrator Basler to sign the agreement. Commissioner Wright seconded. Vote: The motion passed unanimously.

#### Administrator's Report

#### Signatures on election congratulatory letter

Administrator Basler presented the Commissioners with a congratulatory letter for The Honorable Anne M. Beauregard, a recently elected member of the Brockton City Council.

# Cooperative Extension/4-H Update

Administrator Basler presented letters for the Commissioners signatures to be sent to various Boards of Selectmen in towns with newly formed 4-H clubs. Letters will be sent to the towns of Hanover, Middleborough, Norwell, Hingham, Rochester and Scituate. 4-H Director Molly Lipper briefed the Commissioners on upcoming events being held. Awards night will be held January 22, 2016 and The Winter Workshop will be held February 6, 2016 at the Silver Lake Middle School.

Ms. Lipper also informed the Board that over 200 lbs. of food was delivered to the South Shore Community Action for the annual 4-H food drive conducted before Thanksgiving. Commissioner Hanley gave kudos to Ms. Lipper and 4-H Educator Valerie Schell for their continued hard work and dedication to making the 4-H program a success for Plymouth County.

# Vehicle bid sales update

Administrator Basler briefed the Commissioners on the current sales figures for the vehicle bid. November sales totaled \$2.5MM netting \$18,728.48 in management fees for the County and an additional \$19,800 in annual membership dues.

## Recycling Solutions Update

Administrator Basler briefed the Commissioners on Michael Mowbray's continuing work with the transfer station permit change. Mr. Basler is working with Mr. Mowbray on a task list and schedule for the project.

#### Solid Waste Contracts

The County currently has three different services and a recycling service all charging different prices. Administrator Basler will be moving forward with a bid for solid waste contracts and recycling to secure better pricing in January.

Judge Bradley Swearing In at Hingham Courthouse-Friday, December 18, 2015 Administrator Basler and Treasurer O'Brien will be attending the swearing in of Judge Heather Bradley at the Hingham District Courthouse.
