A regular meeting of the Plymouth County Commissioners was called to order at 5:04 p.m. at the Abington Town Hall, 500 Gliniewicz Way, Abington, MA Present were Chairman Daniel A. Pallotta, Commissioner Sandra M. Wright, and Commissioner Gregory M. Hanley. Chairman Pallotta called for the Pledge of Allegiance.

Chief Kevin Nord-Firefighter's Training Facility Update

Mayflower RSVP

Executive Director Darcy Lee thanked the Commissioners for their continuing support of the Mayflower RSVP program.

Dr. Kevin Kelly-Power Management Group

Dr. Kevin Kelly of Power Management Group made a presentation to the Commissioners of a County Energy Program that will allow the County to save money on energy used in County buildings as well as potentially saving money for the member communities within Plymouth County.
